### SHORELINE ENVIRONMENT DESIGNATION

### What is a shoreline environment designation?

Shoreline environment designations work like a zoning overlay. Each designation has standards for development and allowed uses. The purpose of shoreline environment designations is to provide a uniform basis for applying policies and regulations within similar environmental conditions.

There are six environment designations for shorelines in Gig Harbor: **Natural**, **Urban Conservancy**, **Low Intensity**, **City Waterfront**, **Historic Working Waterfront**, and **Marine Deepwater**.

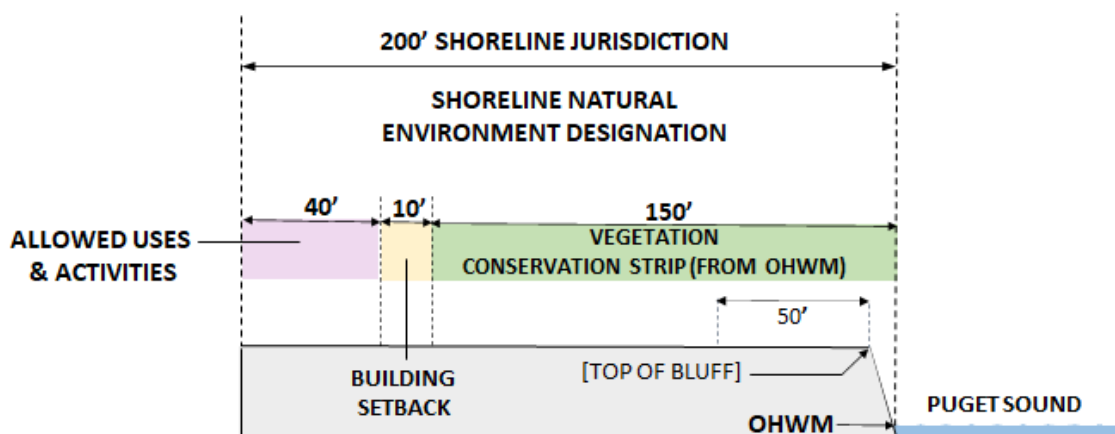
### What is the purpose of the Natural designation?

The purpose of the Natural environment designation is to protect those shoreline areas that are relatively free of human influence or that include intact or minimally degraded shoreline functions that would become irreversibly impaired as a result of human development and activity.

### What is the required buffer in the Natural designation?

A 50-foot wide vegetation conservation strip buffer measured from the top of the bluff or 150-foot buffer from the “ordinary high water mark” (OHWM), whichever is greater, to protect “nearshore” habitat and water quality. In some cases, a larger buffer to protect a critical area might be required. A 10-foot building setback from the buffer is required to limit construction impacts.

Buffers should consist of an undisturbed area of native vegetation. No buildings or structures are allowed in the buffer unless specifically permitted by the Shoreline Master Program. Development activities allowed in the buffer are limited to water-dependent uses, pedestrian pathways and habitat enhancement projects. If development exists, revegetation may be required when the property redevelops.

### Allowed Uses and Activities

#### Clearing and Grading

- activities associated with shoreline restoration
- public access improvement with conditions
- allowed shoreline uses

#### Dredging and Dredge Material Disposal

- dredging to maintain navigational channel at Gig harbor Bay
- dredging for shoreline restoration purposes
- dredge disposal for restoration, remediation, and water-dependent utilities

#### Fill (waterward of OHWM)

- for activities associated with shoreline restoration
- City utility activities

#### Fill and Excavation (upland areas)

- for activities associated with shoreline restoration
- public access improvements with conditions
- for allowed shoreline uses.

**In-Stream Structures** only as part of city of Gig Harbor surface water management activities.

**Recreation** limited to low intensity, passive uses

**Residential Development** for remodels and additions

### Uses Allowed Only With a Conditional Use Permit

**Pedestrian beach access structures** (paths, stairs)

- Publicly-owned only
